- **Minimum Term.** All Memberships are for a minimum period of twelve (12) months.

- **Method of Payment.** Both Credit Cards and Debit Cards will be accepted. Should a payment be declined, Membership benefits will be suspended immediately. To restore Membership, Member must provide an alternative method of payment within thirty (30) days. Membership benefits will be reinstated once Member's account is current.

GENERAL TERMS AND DISCLOSURES

- _____ **Cancellation.** If a Member terminates Member's policy before the end of the Membership, Member must come into the Soderstrom Skin Institute location where the Membership was purchased and execute a Cancellation Form in writing. Member will still be responsible for the remaining balance of the twelve (12) month Membership. No refunds.
- _____ **Delinquency.** A member who continues to be delinquent and falls 90 days or more behind in their payments may be turned over to a collection agency for the full amount of the yearly contract.
- _____ **Transferability.** Memberships are granted on an individual basis, are non-transferable, and are not applicable to other Members of Member's household and/or family. Soderstrom Skin Institute reserves the right to require Member to produce a state issued government identification upon request at appointment check in.
- _____ **Freeze Membership.** Member may freeze Membership one (1) time per year for a maximum of ninety (90) days. Months in which the Membership is frozen will not count toward the twelve (12) month Membership requirement. Member must come into Soderstrom Skin Institute location where the Membership was purchased and execute a Freeze Membership Form in writing.
- _____ **Auto Renewal.** Memberships will auto renew on a monthly basis after the twelve (12) month anniversary. In order to prevent auto renewal, Member must cancel within thirty (30) days of the date of expiration in writing to Soderstrom Skin Institute at the location where the Membership was purchased.
